

IN THE MATTER OF ENACTING AN
ORDINANCE POSTING ROADS AS NO THRU TRUCKS

WHEREAS, it has come to the attention of this Board that due to road conditions, traffic, congestion, and the changing nature of the area served by the county road(s) under consideration and of the discussion; and

NOW THEREFORE, BE IT RESOLVED, Supervisor Jake Gazzo moved that the following ordinance be adopted, with said motion being seconded by Supervisor Samuel Hall:

"ORDINANCE POSTING PIKE COUNTY, MISSISSIPPI
NO THRU TRUCKS ROUTES"

It shall be unlawful for any person to drive a truck with more than six tires, with the exception of school buses and service trucks, through the following routes:
