Pike County Crime Commission

Purpose

Appointed by the Pike County Board of Supervisors, the Pike County Crime Commission galvanizes a diverse group of leaders and stakeholders who seek to improve public safety in Pike County by studying crime and identifying and promoting evidence-based best practices. The overall function of the Pike County Crime Commission is to make recommendations to city and county officials concerning crime prevention activities and serve as a conduit between law enforcement, criminal justice agencies, and Pike County citizens.

Goal

To identify innovative and evidence-based violence reduction strategies and community-based solutions through comprehensive planning that establishes clear goals, objectives, and priorities that increase public safety and public confidence.

Commission Composition, Qualifications & Term Length

The commission is composed of twelve members appointed by the Pike County Board of Supervisors, serving a four-year term. Each member shall be a resident of Pike County for at least two years. Members of the commission may be law enforcement, crime prevention, clergy, education, persons of lived experience, advocates, and elected officials. The Board must appoint at least one (1) supervisor to chair the commission.
